## Collection Efforts:

From January 1, 2021 through April 28, 2022, our collection rates for 2021 taxes are as follows:

99.25% of 2021 real estate  
96.37% of 2021 personal property

Per the County's audited Financial reports for the last two fiscal years ending June 30, we have collected delinquent taxes as follows:

\$1,737,101 FY2021  
\$1,266,659 FY2020

Delinquent notices are sent out following the June and December collection periods. Unpaid tax accounts will be pursued, resulting in additional fees. ***If you are unable to pay by the due date on the delinquent notice or have fallen behind on your taxes, it is important that you contact us.***

***Please resolve questions on tax assessments and adjustments promptly:***

*If you own a vehicle in Greene on January 1<sup>st</sup>, you will owe tax to Greene County for the entire year. Please call the Commissioner of Revenue's office at 434-985-5211 for questions on assessments or adjustments.*

*After **90 days**, bills will be considered accurate.*

**Did you know?** The annual tax bill is sent in May with two payment stubs. Please retain this bill for your December payment.

**WHEN MAILING A PAYMENT**, please send stubs and/or account numbers. Include a phone number in case we have questions. Do not attach stubs to checks or tape the envelope corners.

All payment options are located on the back of the tax bill and online.

**REDUCE THE STRESS OF TAX TIME  
BY PREPAYING YOUR TAXES:**

Simply submit your monthly or quarterly payment along with the account number where the payment should be applied. If paying multiple accounts, please provide account numbers and specific amounts for each. Include a phone number in case we have questions. If receipts are needed, include a self-addressed stamped envelope with your payment. Please call the office with questions.
